

S&M Slave Girl Contract

I the 'Slave' hereby understand that the S&M Slave Girl Contract is a transfer of power exchange in 24 hours a day, 7 days a week, each day of the year being (24/7) between consenting partners. Upon my own free will I the Slave/ Bottom should fill out this questionnaire to the best of my ability to help the Dominant/ Top carefully assess all fears and limits before the beginning of my slave training and participating in the "BDSM Scene". There is plenty of room for excitement, fear, and mind-blowing domination within the slave's limits. The purpose of the questionnaire is for a SAFE, SANE and CONSENSUAL power exchange in 24 hours a day, 7 days a week, each day of the year being (24/7).

I, _____ the undersigned, bind myself totally and completely, without limits to, slavery to the Dom/ Top of this contract, herein after known as _____ .

I certify that I am at least 18 years old, am not now physically or mentally impaired by an influence of drugs, including alcohol, or other reason where I do not know what I am doing. I am legally and mentally competent to contract in my own name. I am signing this document of my own free will, without coercion or pressure of any kind. No one has made any promises, guarantees, warranties or offered threats or inducements of any kind to get me to sign this Contract. With a full understanding of the meanings and implications of this Contract, I specifically desire and request the control delineated and the activities mentioned herein. I specifically desire and request _____ to force me to comply, if necessary, using any means at _____ disposal.

I, _____, agree to voluntarily give up all rights, personal and legal, and become the personal property of _____ M, hereafter called "Dom/ Top"; and, whereas The Dom/ Top has accepted The SLAVE as legally titled property, the purpose of this S&M Slave Girl Contract is to codify and enforce the property rights of the Dom/ Top over the SLAVE.

I understand the Government of the United States prohibits slavery and involuntary servitude. Nevertheless, for my own purposes, I desire to become and be a slave. I am signing this Contract in an attempt to affect that status. I specifically request the courts, the law and government not to interfere. I consider any attempt by an outside authority to in any way limit _____ rights and prerogatives under this Contract to be an unwarranted interference with my constitutional legal right to privacy. I am of legal age and I am legally an adult who knows what it is doing. I specifically want slavery. In the strongest language, I request the government not to protect me from the consequences of this decision. I give up any and all rights of any kind and description. My body, mind, and soul from this day, will be the absolute total property of my _____. I specifically waive any and all protection in law or equity, any constitutional rights or protections, and any other rule or regulation that would in any way prevent _____ from having total control over every aspect of my life. I desire to be placed in a position where I CANNOT change my mind.

I agree with the following clause, which makes this contract almost impossible to break. First, the Dom/ Top of the slave can only cancel it, it's _____. Once the slave is enslaved it can never leave slavery unless the _____ allows its freedom or a dated termination is set within the S&M Slave Girl Contract.

DEED of OWNERSHIP

I hereby called "The Slave" _____, agree to voluntarily give up all rights, personal and legal, and become the personal property of my _____ "Dom/ Top"; has accepted The Slave as it's legally titled property, the purpose of this S&M Slave Girl Contract is to clarify and enforce the property rights of the Dom Top over the Slave.

The Slave agrees to become the property of and to submit completely to The Dom/ Top in all ways. There are no boundaries of place, time, or situation in which The Slave may refuse to obey any wish or order of The Dom/ Top. The Slave will never be given the option to act on its own desire but will be trained to complete obedience by a combination of systematic humiliation and punishment. The Slave's status and duties are permanent and will be performed 24 hours a day, 7 days a week, each day of the year whether The Dom/ Top is present.

I hereby called "The Slave" _____, understand the following,

1. The Dom/ Top is responsible for the health and the mental/ physical safety of the Slave.
2. The Slave's sole purpose in life is to make its Dom/ Top happy.
3. The Slave will obey the Dom/ Tom at all times.
4. The Slave will renounce all rights and privacy.
5. The Slave fully understands that failure to obey the Dom/ Top shall be regarded as sufficient cause for possible punishment.
6. The Slave understands that it is the sole property of the Dom/ Tom up until the termination of the S&M Slave Girl Contract.
7. The Slave understands it will serve the Dom/ Top 24 hours a day, 7 days a week, each day of the year.

I, the undersigned participant, hereby apply for slavery with the Dom/ Top, _____ (Real Name Here). By placing my signature below, I acknowledge that I have read and will be required to comply with all of the Terms and Conditions of the S&M Slave Girl Contract as set forth in this Agreement. I understand and intend for this application to constitute a legally binding agreement between the undersigned and the Dom/ Top.

By signing the S&M Slave Contact I understand this a Slavery AGREEMENT and LEGALLY BINDING. Upon completion and signature, you will become obligated to make all the necessary changes that had been told to you.

Failure to comply with the Agreement will result in punishment or the loss of privileges as seen fit by the Dom/ Top.

DO NOT SIGN UNTIL YOU READ THE AGREEMENT AND UNDERSTAND THE TERMS COMPLETELY.
